



## Spay/Neuter Agreement

Registration of this dog is contingent upon the purchaser's compliance with this Agreement. Proof of the dog's spay must be received by the purchaser within (14) days after the surgery, and within three months of purchase, or seven months of age, whichever occurs first. In the event that the dog's health does not allow spaying within required time frame, Peredo's Pedigree Puppies (the Breeder) must be provided with a statement from evaluating veterinarian that this dog is not in physical condition for surgery; this statement should include the earliest date that the procedure can be performed.

It is the responsibility of the Purchaser, not the veterinarian, to ensure that the Breeder has received verification that the surgery has been performed. Failure to comply with this agreement by the required date, unless otherwise agreed to in writing, will be considered a breach of the contract, and Purchaser will pay to transport, or provide transport of, this dog back to the Breeder and will not be entitled to a refund. Further, the dog will not be eligible for registration.

Option two: If you purchased a puppy for pet and family purposes, and later decided to breed the dog or bitch, then the difference of price is due payable to the breeder, Peredo's Pedigree Puppies. The price difference from pet price to full value breeding stock price is three to five times the pet price (never less than \$1500. This shall become due and payable to Peredo's Pedigree Puppies at once and as soon as possible, not to exceed 30 days before the remaining difference and balance is paid in full and total.

By my signature below, I agree to have this dog spayed/neutered by no later than 3 months from purchase date or seven months of age, whichever occurs first, and I understand that this spay/neuter agreement is an agreement that this dog will not produce a litter of puppies either as purposely bred or by accidental breeding. Accidental breeding is considered neglect and the dog/bitch will be returned to us and all puppies born from any breeding, accidental or otherwise, will become the property of Peredo's Pedigree Puppies. I also agree that should puppy not be spayed that I will return said puppy back to Peredo's Pedigree Puppies with no refund.

This means that you will be granted temporary ownership of this puppy. Upon our receipt of this puppy's proof of spay from your veterinarian, you will then be supplied with a permanent transfer of ownership. Failure to provide to the breeder the proof of spay of this puppy by 7 months of age will nullify this agreement and the purchaser will deliver or pay to deliver the puppy and return it in good health to the breeder and surrender puppy to breeder without financial restitution or compensation of any kind.

In the case of the puppy's demise on or before the above listed date, a written statement from your veterinarian must be sent to Peredo's Pedigree Puppies, stating that the puppy has indeed passed away, and the cause of death. This is an unfortunate step but necessary.

Also, in a perfect world we would like to have each puppy we place to stay in their original purchasing home. Buyer agrees to contact Peredo's Pedigree Puppies, in writing, phone or email BEFORE the puppy has been placed into a new home. This contract is still your responsibility to enforce in the puppy's new



home, should we not receive conformation of the puppy's spaying or neutering by the above listed the original purchaser, you will then be liable for the dogs full purchase breeding value.
